

Privacy Policy

This website is operated by Albany Grange Limited t/a The Martin Veasey Partnership. Our principal activity is the provision of recruitment and associated services, and we are located in the United Kingdom. Information and communication technologies play a fundamental role in our business. This privacy statement describes how we collect and use personal information about people who visit our website. By visiting this website you are accepting and consenting to the practices described in this Privacy Statement.

INFORMATION ABOUT VISITORS TO OUR WEBSITE

You can access the home page of our website, browse the site and search for job vacancies without disclosing your personal details.

We gather general information about the use of our website, such as which areas users visit most frequently and which services users access the most. We only use aggregated data which cannot identify an individual visitor to our site. HOW WE USE YOUR PERSONAL INFORMATION

The Martin Veasey Partnership will use your personal information to administer services in connection with this site, including your registration and any job applications or other recruitment or associated services that you request. We do not collect any other personal data through the website, nor do we use personal information collected through the website for any other purposes.

We will process your personal information fairly and lawfully, and in accordance with national data privacy laws.

WHERE YOUR PERSONAL INFORMATION IS STORED

If you choose to register, your personal information will be stored by The Martin Veasey Partnership on our central database which is located in the United Kingdom. Your personal information will be accessed and used by The Martin Veasey Partnership for opportunities in the United Kingdom and for opportunities outside the United Kingdom only if have asked us to inform you of job opportunities in those countries.

CONSENT

By submitting your personal information, you consent to the use of your information as set out in this privacy policy.

DISCLOSING INFORMATION

The Martin Veasey Partnership will not disclose the personal information that you provide (such as your name, address, email address, telephone number or career history), or details of your individual visits to this website, to any outside parties except:

- as necessary for job applications or other recruitment or associated services that you have requested,
- with your consent, or
- when we believe the law requires it.

However, we may record and share general information about the use of our website with our business partners, as described above.

CVS

If you provide a CV, it is your responsibility to ensure that it is accurate and kept up to date. If you provide details of a referee, it is your responsibility to ensure that the person is aware that you have forwarded his/her details and is happy for you to do so.

SECURITY

The Martin Veasey Partnership is committed to protecting the security of your personal information. We use a variety of measures to ensure that your personal information (including the information in your CV) is protected from:

- unauthorised access
- improper use or disclosure
- unauthorised modification or alteration
- unlawful destruction or accidental loss

However, the Internet is an open system and The Martin Veasey Partnership cannot guarantee that the personal information you submit will not be intercepted by others. You should be aware that the CVs you complete at your current place of work may be monitored by your current employer.

All our employees and agents who have access to or are involved in the processing of personal information respect the confidentiality of personal information.
